- **Construction Management Coordinated Insurance Program (CMCIP):**
 - Program under which Workers' Compensation, Employer's Liability, Commercial General Liability, Excess Liability and Builder's Risk are procured or provided on a project "wrap-up" basis for contractor/subcontractor(s) of any tier, who have been properly enrolled, while performing operations at the Project Site.
 - Program does NOT cover consultants, suppliers, vendors, materials dealers, guard services, janitorial services, truckers and other temporary project services.

- **Bonding:**

- 20% Bid Bond

- 100% Performance/100% Payment

- **Construction Labor Agreement (CLA):**

- Subcontractor and all lower-tier subcontractors will be required to become signatory to the CLA, signed between the Signatory Employers and the Signatory Unions of the Knoxville Building and Construction Trades Council, AFL-CIO.

- **Office of Federal Contract Compliance Program (OFCCP):**

- Notice required for all construction subcontracts awarded in excess of \$10, 000
- Monthly labor utilization goal reporting required
- Established Goals:
 - Minorities 6.8%
 - Women: 6.9%
 - Veterans: Good Faith Effort
 - Individuals with Disabilities: Good Faith Effort

• **Small Business Subcontracting Plan:**

–Small Business Goal	40%
–Small Disadvantaged Business Goal	15%
–Small Woman Owned Business Goal	5%
–HUBZone Business Goal	.5%
