f. Reference Section E; Summary of Work, paragraph 1.8.B: Change date for Complete Structural Steel Erection to read “February 05, 2003” vs 2002.

g. Reference Section E; Summary of Work, Attachments: Add “Attachment 3, Elevation **Sketch C-SK-.067**. Sketch C-SK-067 provided herein (information only).

h. i. Reference Section H; Exhibit 13, **Construction Labor Agreement**: Delete “Boilermakers’ Local No. 453” and “Electricians’ Local No. 270” and replace with attached wage sheets.

j. The **closing date is hereby changed to March 26, 2002** in lieu of March 19, 2002; resulting in a one-week extension.

k. All other terms and conditions remain unchanged.
